## EXTRACT COPY OF SCHEME OF TAKING OVER THE WORK RELATING TO RECOVERRY OF PENSION CONTRIBUTION FROM AG(A&E) RAJ. JAIPUR.

- 1. In furtherance to the decision taken by the State Government to take over the work relating to the recovery of Pension Contribution in respect of State Government employees proceeding on deputation/foreign service, a scheme has been formulated by the State Government for the proper upkeep and maintenance of records relating thereof. The broad features of the scheme are outlined in the subsequent paragraphs.
- 2. The Directorate of Pension, Government of Rajasthan will be entrusted with the responsibility of proper maintenance of prescribed registers and records relating to this scheme and to watch regular and timely recoveries of pension contributions from foreign employers.
- 3. The Appointing Authorities shall, while issuing orders of deputation of Government Servants, endorse copies of all such orders to Director, pension Department, Rajasthan, Jaipur.
- 4. The foreign employer will, either at the end of financial year or at the end of deputation period, whichever is earlier, send a statement in form C-4 along with a copy of challan/draft/cheque, showing therein the details of pension contribution deposited / remitted by him.
- 5. (a) The Pension Contribution for the preceding year would be accepted upto 30<sup>th</sup> April of ensuing year without any penal interest. In case however, the due amount is not deposited by this date, penal interest would also be charged for this period. All such demands will be computed by the end of June each year.
  - (b) The amount of pension contribution will be deposited through challan under the budget head:-
    - "0071-- Contribution and Recoveries towards pension and other retirement benefits.
      - 01 -- Civil
      - 101-- Subscription and contributions.
        - 1-- Contribution for pension & gratuity".
- 6. (a) The amount of pension contribution could also be remitted to Pension Department by bank draft or crossed cheque drawn in favour of Director, Pension Department, Government of Rajasthan Jaipur. The date of receipt of cheque would be treated as date of receipt of the amount of pension contribution.
- (b) The existing arrangements under which cheques/ drafts towards payment of pension contribution are sent by the foreign employers to A.G. (A&E) Rajasthan shall stand discontinued w.e.f. the date of taking over of this work by the State Government. If even after the said date, cheques/draft are received in the office of A.G.(A&E) the same will be returned to the drawer with the advice to send the same to Director, Pension Department, Government of Rajasthan Jaipur.

- 7. The Pension Department will maintain a Pension Contribution Collection Register (C-6). All the challans, cheques, drafts received on account of pension contribution will be entered therein and monthly totals will be struck and reconciled every month with the figures of A.G. (A&E) Rajasthan.
- 8. The Pension Contribution will be recovered @ 12% of the maximum of the scale of the post held by the Government Servant in his parent department. The Pension Contribution will be calculated for full month. For the aforesaid purpose, fraction of a month exceeding 15 days would be treated as full month and a fraction upto 15 days would be ignored.\*
- 9. In case an employee is deputed to such body which is not wholly and substantially owned or controlled by Government of Rajasthan, the Pension Contribution @ 12% of the maximum of the scale of the post held him in his parent Department along with leave salary contribution @ 11% of the pay being drawn by him, would be recovered from the foreign employer/concerned employee for the period of such deputation. If, however, as per terms and conditions of his deputation orders, no leave is earned by the Government Servant during the period of such deputation, leave salary contribution would not be recovered in such cases.
- 10. The concerned department and the foreign employer will invariably endorse copies of orders relating to deputation, extension and posting etc. etc. to Pension Department.

## **NOTIFICATION**

Sub.: - Amendment in Rajasthan Service Rules, 1951 - Volume-! - Part A.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Rajasthan hereby makes the following rules to amend further the Rajasthan Service Rules, namely:

- 1. These rules may be called the Rajasthan Service (Amendment) Rules, 2009.
- 2. They shall come into force with effect from 01.01.2007.
- 3. In the Rajasthan Service Rules -

the existing para 4 of the Government of Rajasthan's Decision below Rule 145 of Rajasthan Service Rules substituted vide Finance Department Notification No. F.1(20)FD(Gr.2)/84 dated 01.03.1990 shall be substituted by the following, namely: -

It has been further decided that the pension contribution for each month of deputation, shall be paid @ 10%of the sum of pay in Running Pay Band, Grade Pay and Dearness Allowance of the post which the deputationist would have held in his parent cadre at the end of the financial year concerned or at the end of foreign service if reverted before close of the financial year. For the aforesaid purpose a fraction of month exceeding 15 days would be treated as full month and a fraction upto 15 days would be ignored. The rate of contribution so payable by the borrowing authority or foreign employer shall invariably be indicated in the order issued by the competent authority regulating his terms and conditions of deputation so that contribution for pension due in respect of a Government servant in foreign service is paid within one month from the end of each financial year or the end of foreign service, if the deputation on foreign service comes to an end before close of the financial year as envisaged in Rule 149 of Rajasthan Service Rules."
