**No.F.15(3) FD (Rules)-97
Jaipur, dated August 8, 2000**

In exercise of the powers conferred by the proviso to Article 399 of the Constitution of India, the Governor hereby makes the following rules further to amend the Rajasthan Civil Services (Pension) Rules, 1996, namely :-

1. These rules, may be called the Rajasthan Civil Services (Pension) (Amendment) Rules. 2000.
2. These rules shall be deemed to have come into force with immediate effect if shall also be applicable to the cases pertaining to the period before issue of this notification but with immediate effect.
3. In the aforesaid rules :-
 - (i) below the existing clause (iii) of Rule 62 a new clause (iv) shall be inserted, namely :-

"(iv) Notwithstanding anything contained in clause (ii) and (iii) the amount of family pension in the case of parent shall be as admissible in clause (i)".
 - (ii) The existing clause (c) and (d) of sub-rule (1) of Rule 66 shall be substituted by the following , namely :-

"(c) son/daughter including widows/divorced daughter till he/she attained the age of 25 years or on earning a monthly income exceeding Rs. 2550/- or upto the date of his/her marriage/remarriage whichever is earlier. The term son/daughter shall also include son/daughter adopted legally and posthumous child of a Government servant.

(d) parent who were wholly dependant upon the Government servant when he/she was alive provided the deceased employee had tell behind neither a widow nor a child and the inconfo of patent is not more than Rs. 2550/- per month.
 - (iii) The existing clause (b), (c) and (d) of Rule 67 shall be substituted by the following, namely :-

- (b) Unmarried son till he attains the age of twenty five years or on earning a monthly income exceeding Rs. 2550/-
 - (c) daughter including widowed/divorced daughter till she attains the age of 25 years or on earning a monthly income Rs. 2550/- per month or upto the date of her marriage/remarriage, whichever is earlier.
 - (d) parents who were wholly dependent upon the Government servant, when he/she was alive provided the deceased employee had left behind a widow nor a child and the income of parent is not more than Rs. 2550/-
- (iii) The "Explanation (1)" appearing below Rule 67 shall be substituted by the following namely :-
- "(i) A son/daughter shall become ineligible for family person from the date he/she gets married or on earning a monthly income exceeding Rs. 2550/- per month. He/she will be required to produce six monthly a certificate regarding marital status and and annual certificate regarding monthly income."
- (v) Below existing clause (d) or Rule 68, the following new clause (c) shall be inserted, namely :-
- "(c) where the family pension is payable to parent it shall be paid first to the mother and after her death it shall be payable to the father.
4. The past cases decided otherwise need not be re-opened but hence forth they will be regulated in accordance with the provisions amended by this notification.
